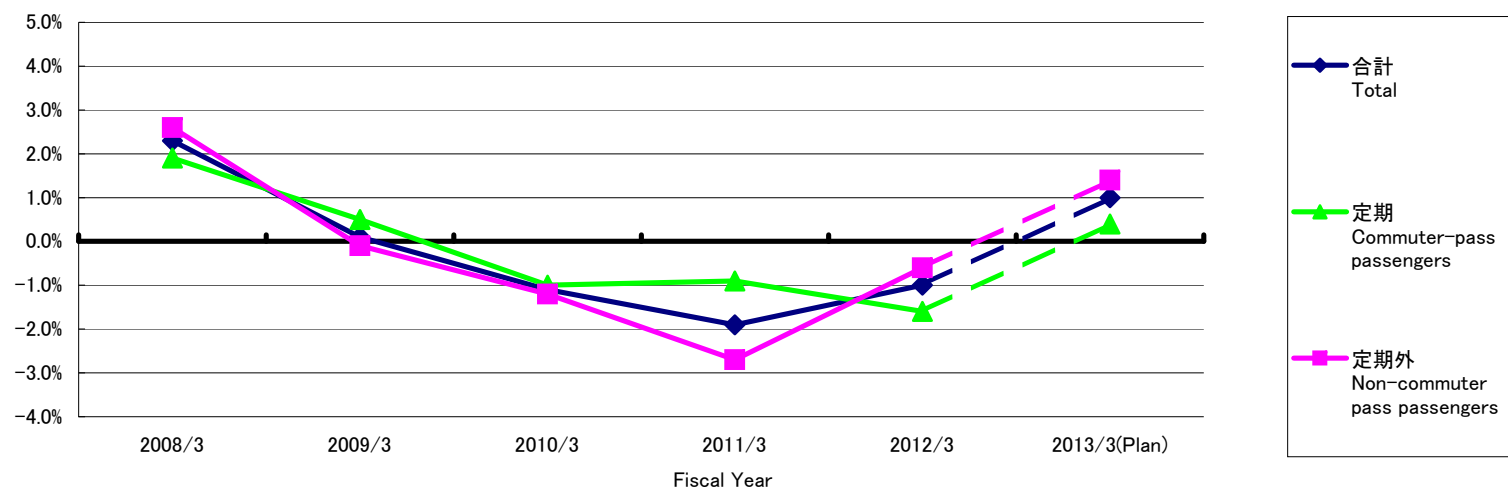

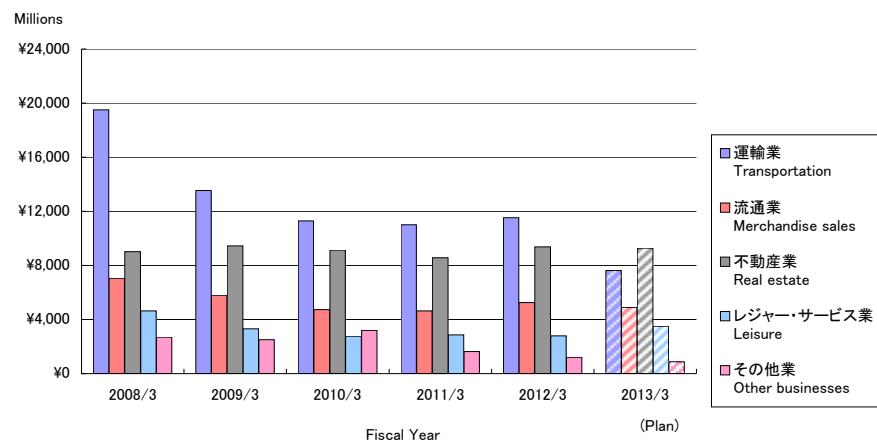

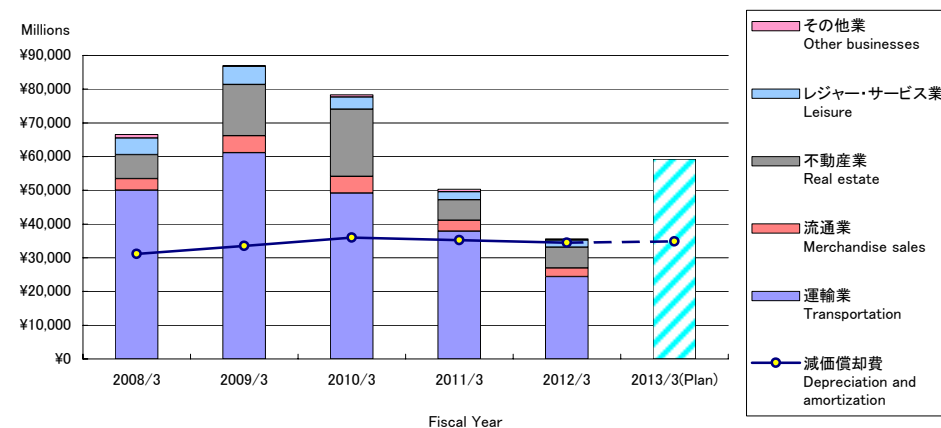

減価償却費と設備投資 Depreciation and amortization & Capital expenditures



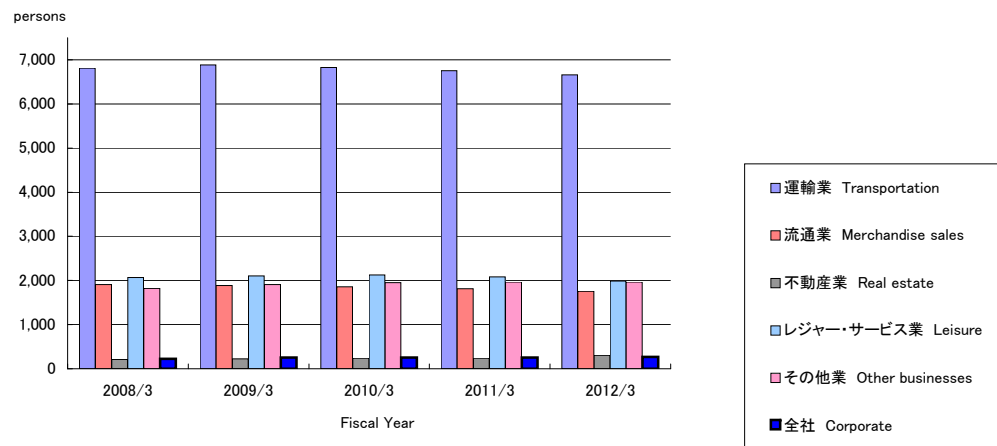
