Cash and cash equivalents at end of year



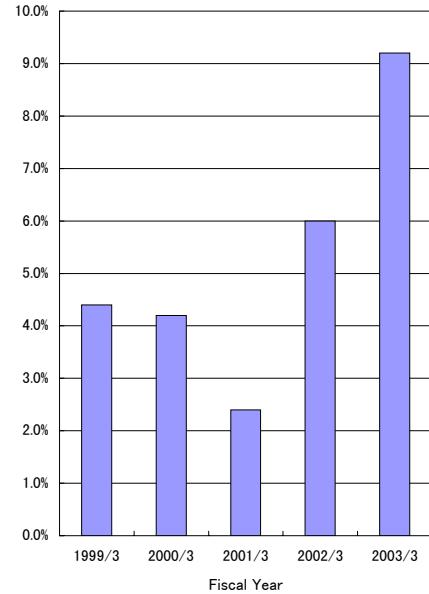

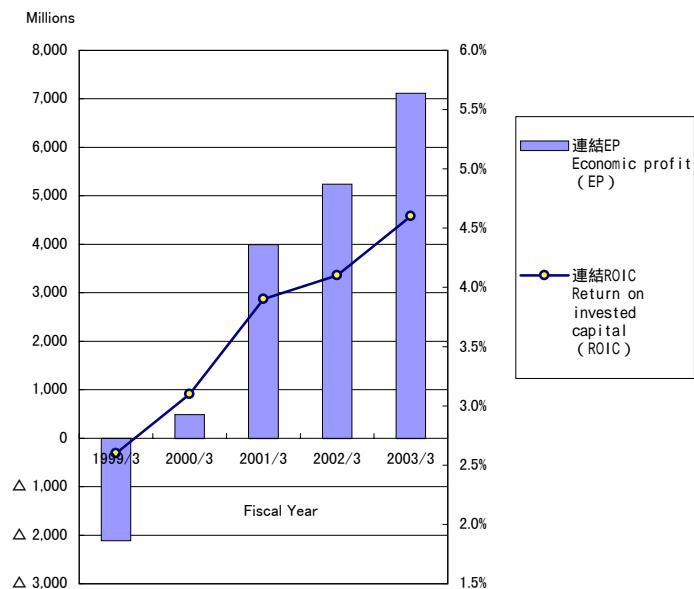

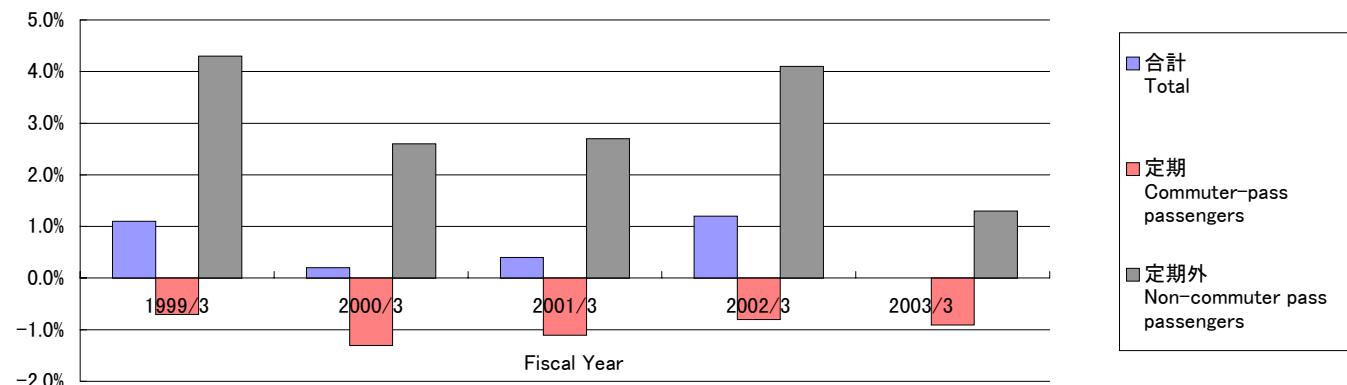
